I have also had experience in acting as counsel for parties in numerous arbitrations as well as for court related applications concerning arbitration matters.

For my Mediation experience, I was accredited by HKIAC in 2002. Since then, I have had over 70 cases of Mediation including inter alia from referral from HKIAC, FDRC, Building Management Mediation Pilot Scheme for Lands Tribunal cases, JMHO and from parties' appointment. As to the natures of Mediation cases, that would include land disputes,

building management disputes, shareholders' disputes, construction disputes, contractual disputes, financial products disputes, sales of goods disputes, personal injury disputes, probate disputes, auditors' negligence disputes and so on.
