He has experience in sitting as a member in various statutory tribunals in Hong Kong including the Board of Review, the Registration of Persons Tribunal, the Guardianship Board, the Obscene Articles Tribunal. From April 2013 to April 2018, he was the Chairman of the Appeal Board for the Hotel and Guesthouse Accommodation, Bedspace Apartments and the Clubs (Safety of Premises). On 1 July 2018, he was appointed as Justice of the Peace by the Government of the HKSAR.
