

Biography of Ms. Sin Kar Yu Jody

Jody Sin is a solicitor in Hong Kong, and has been accredited by various local and international bodies, including the Hong Kong International Arbitration Centre (HKIAC), HKMAAL, the Law Society of Hong Kong, International Mediation Institute and she is a member of the United Nations Global Mediation Panel. Ms. Sin mediates a broad spectrum of disputes, covering employment, discrimination and workplace issues, professional indemnity claims, shareholders and partnership disputes, probate disputes, defamation, personal injuries and insurance. Ms. Sin teaches mediation and conflict resolution at the Faculty of Law of the University of Hong Kong and Chinese University of Hong Kong. She is also an adjunct professor of the University of Hong Kong School of Professional and Continuing Education (HKU SPACE), a certified trainer of MTI, and a CINERGY-certified conflict management coach.

In 2019, Ms. Sin was awarded JAMS Weinstein International Fellowship and is a Senior Fellow of Weinstein International Foundation. She has been a Distinguished Fellow of International Academy of Mediators (IAM) since 2016 and has become a member of the Board of Governors in 2020.

Ms. Sin is currently the Vice-Chairperson of Hong Kong Mediation Council, a division of the HKIAC. She is also a member of the Steering Committee on Mediation of the Department of Justice under the Secretary for Justice, Hong Kong. Besides, she sits in the Mediation Committee and the Mediator Admissions Committee of the Law Society of Hong Kong.
